Purpose/Narrative:	To subdivide a 99.86 ac tract parcel # 08250002 into 16 residential lots on West Duncan Road. Each lot will have access to West Duncan Road (NCDOT maintained) therefore no subdivision roads are required. No street lights are planned. The plan has been reviewed by NCDOT and they have provided comments to the developer about driveway permits. Two lots (#15 and 16) that are next to Goose Creek will comply with all NCDER requirements in respect to the buffer and crossing the creek. No County water will be provided. Each lot will have its own water and septic.

Staff Recommendation on Application:	As you know, water and sewer development is mainly expended by development. It is the opinion of the Land Use administrator that the developer provides water to the homes planned rather than wells. The developer now plans			

to have well and septic on each lot. The Developer has stated the Union County water is available approx. 1,000 feet away at Howey Bottoms and West Duncan Road. Union County has had problems with arsenic in wells and of course it is a problem in Fairview.

In addition if water was provided, additional fire protection would be provided with fire hydrants.

I understand providing water would be some cost to the developer (between \$35 and 45 thousand dollars a foot) but I feel it would benefit these residents and the Town of Fairview, For the reasons above staff would not recommend approving the permit.

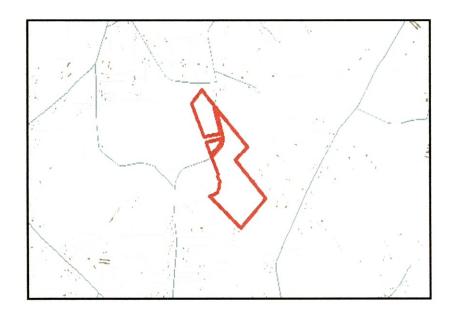

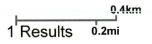

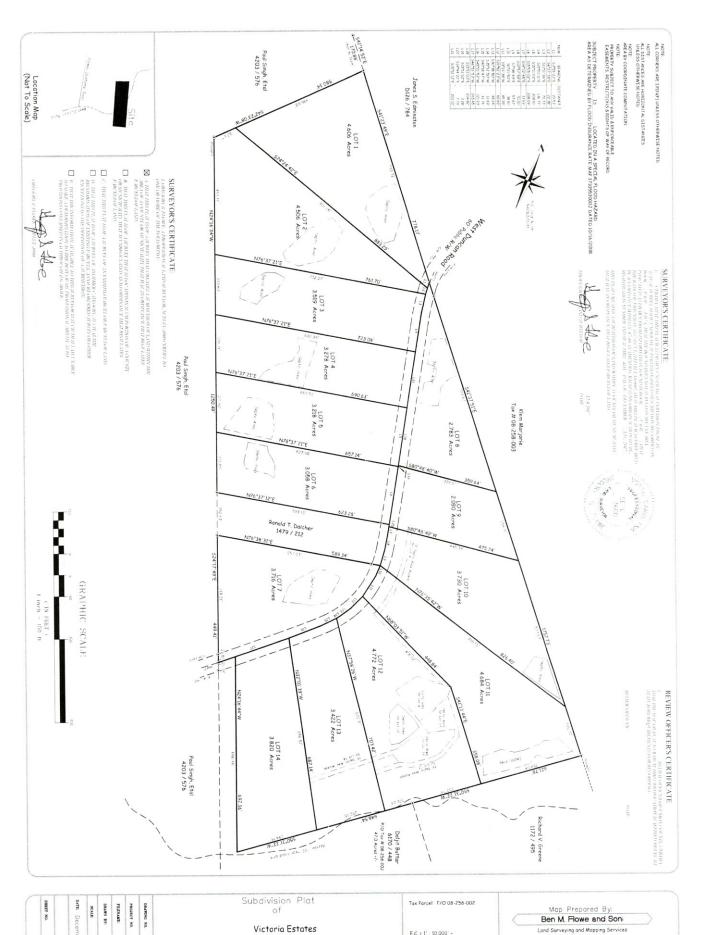

The following Planning Board members were present: John Crowell, Tony Helms, Patricia Kindley, Rick Pigg, Doug Buchanan and Sara Furr

Reports

Ed Humphries stated that the Festival Committee has made plans to hold a Winter Festival on December 9th. The Winter Festival will include a tree lighting and visit from Santa among other things.

The Council approved an amendment to the Fairview Noise Ordinance (making it illegal to operation a motor vehicle that has had its muffler-exhausts and/or noise —control equipment removed, altered or maintained in such disrepair as to create unreasonably loud and disturbing noises) that had been requested by the Sheriff's Department attorney.

The Council approved the Fairview Fall Festival to be an annual event.

Brian Matthews, Union County Executive Director Growth Management updated the Council on several projects including the Monroe Expressway and an additional library for the county.

Mr. Humphries also noted that there are a few openings on the Planning Board and asked the Board to let him know of anyone that they knew of that would be willing to serve and that they felt would be a good fit to the Board.

Items of Business

A. Finalize the "Table of Uses" for recommendation to the Town Council

Mr. Humphries presented the Table of Uses with changes for the Board to review. The Board discussed the changes and made their recommendations.

Patricia Kindley made a motion to recommend the Table of Uses with the changes agreed on to the Council. Sara Furr seconded the motion. Members Crowell, Helms, Kindley, Pigg, Buchanan and Furr voted yes (6-0).

B. Discuss the Future Land Use Plan for possible changes

Mr. Humphries presented the "Future Land Use Plan" showing the revised business (B4)/highway commercial (HC) area for Fairview. The Board discussed.

Rick Pigg made a motion to present the revised "Future Land Use Plan" map to the Council. Doug Buchanan seconded the motion. Members Crowell, Helms, Kindley, Pigg, Buchanan and Furr voted yes (6-0).
